

Rules of the Game :

“Car and Luxury Holiday Prize Competition” by ScarletHill Enterprises Corporation

The prize competition (hereafter referred to as the Game) organized by ScarletHill Enterprises Corporation (as the owner of Oxywat brand, hereafter referred to as the Organizer) may only be entered** by a natural person* (hereafter: the Player) who is a legally permanent UK resident*, of at least 18 years of age* who is of sound mind* and who buys**, during the duration of the Game**, at least one Oxywat SET from the <http://oxywat.co.uk> website.

Short description of the promotion

"Buy at least 1 Oxywat SET product from the Oxywat.co.uk website for a chance to win 1 high-value vehicle or one of 5 luxury trips for 2 people! More details can be found on the www.Oxywat.co.uk/prize_competition website. "

All customers who purchase at least 1 Oxywat SET product will be entitled to participate in the prize draw

* Prizes :

- 1 new car
- 5 x 1 Luxury Trips for 2 people

1. Contest Duration:

- Purchases can be made from 1st September 2015 on the Oxywat.co.uk website. The game has no time limit; the prize draw will take place based on the quantity of sets that are sold.
- The game ends on the date on which the 500th Oxywat SET product is sold.

2. The product that has to be purchased to be able to participate in the prize draw is an Oxywat SET

3. After making a successful purchase ** the user will automatically be added to the list of contestants.

4. Prize draw:

- Luxury trip: the prize draw will take place on the 31st day after the receipt of the 100th successfully purchased Oxywat Set or on the first working day thereafter.
- During the entire period of the game 5 luxury trips for 2 people will be offered.
- Vehicle: the prize draw will take place on the 31st day after the receipt of the 500th product that is sold or on the first working day thereafter.
- The prize draw for the Car will take place at the same time as the draw for the fifth Luxury Trip.
- Successful Luxury Travel Contest Winners may not also be entered into the prize draw for the Car.
- The draw will not be made in public. It will take place in the presence of a notary, will be randomized and will be done by hand.
- Winners will be disqualified if their bids for the prize draw are found to be invalid.
- Winners will be notified by postal and electronic mail about how they can receive the prize.
- Each purchased item has a unique order identifier/code on which inclusion in the prize draw will be based.
- A player can purchase several products, but all purchases must be separate orders to ensure participation in the game.

5. The Organizer is entitled to examine the veracity of a player's personal data through contacting the player, irrespective of whether such player is the winner.

6. If the winner is not contactable through the given e-mail address, postal address or phone number provided through the Game, the organizer will do their utmost for 14 calendar days from the first time of notification of the winner to get in touch with him/her. If the winner cannot be reached within 14 calendar days from the day when the Organizer first attempted to contact him/her, the prize draw will be repeated.

7. After a win has been verified, the Organizer will to hand over the prizes to the winning Players in person. The date of the handover will be defined on the basis of mutual consultation. The Winning Player is obliged to cooperate with the Organizer in order for the prize to be successfully handed over to him/her within 90 days of the conclusion of the draw.

8. If a winner's ability to exercise their legal rights is limited, then he/she shall only be entitled to undertake administration related to the prize draw and to receive a prize when accompanied by a legal representative. The Player acknowledges that the content, performance, messaging, data and response speed of the technical infrastructure of the "Scarlethill - Prize Competition Car and Luxury Holiday" game is dependent on the technology employed and may be adversely affected by factors outside the organizers' scope, such as (but not exclusively) connection failures, server computers' performance or the maintenance of a secure network connection.

The Organizer assumes no responsibility if the system is overloaded, the Internet connection is lost, or any other technical error or obstacle not attributable to the organizer occurs, due to which participation in the game, in particular logging on to the site as a member or the submission of applications, is delayed or does not succeed.

The Organizer is excluded from any liability arising from occurrences in connection with the game as listed in the paragraph above.

9. If for any reason the Player does not meet the conditions laid down in the present Rules of the Game, the Organizer may exclude the Player concerned from the Game.

10. The Organizer is entitled to exclude a player from the Game who attempts to unfairly participate through bypassing the conditions and limitations contained in these Rules.

11. If during the Game misconduct or unfair play is suspected which may lead to abuse, the Organizer reserves the right to suspend or cancel the Game.

12. The Organizer reserves the right to exclude any Player from the Game, as well as initiate a claim for compensation not excluding the initiation of criminal proceedings against the Player if he/she a) attempts to gain an advantage during the Game by hacking or in any way interfering with the internet pages of the Game or using other dishonourable means to manipulate game-related data; b) abuses another Player's registration data (e.g. e-mail address).

13. The Organizer shall not be liable for problems arising from delays or cancellations by third parties such as couriers. The Organizer assumes no responsibility for any delays/failure to notify or deliver due to provision of erroneous data.

14. Prizes are non-transferable and cannot be exchanged for cash. The PITA payment liability arising from the prizes will be borne by the Organizer but other costs that are incurred shall be borne by the Player (e.g. Travelling expenses in connection with the handover of the prize).

15. By the Purchase of the product the Player acknowledges that he/she vouches for the accuracy of his/her data. The Organizer assumes no responsibility for any delays/failure to notify or deliver due to provision of erroneous data.

16. The Organizer will provide no warranty with respect to the prizes; winners may assert such claims within the legal framework against the manufacturer/dealer of the prize. (Oxywat.co.uk)

17. The Organizer will announce the list of the winners on the internet address www.oxywat.co.uk within three days after the prize draw. In this announcement, the name and address (with an indication of the settlement) of the winning Player(s) will appear.

18. With the participation in the Game the Player:

- gives their unconditional, explicit consent that his/her name, email address, phone number, permanent address, and, in the case he/she wins, other personal data indispensable for the communication of the winners' list and the handover or receipt of the prize may be used by the Organizer and the people involved for the purpose of conducting the game, in accordance with the laws on the right to informational self-determination and freedom of information;

- acknowledges that at the handover of the prize video, voice and movie recordings can be made, and, at the same time, consents that the whole or parts of these recordings may be used in advertising / for promotion regarding the present prize competition or later events, without time or territorial limitation or restriction on their number of uses and without additional compensation;

- agrees unconditionally that the Organizer may use his/her data during the conducting of this Game; furthermore, that the data may be forwarded to the data processor in charge of processing the data provided by him;

- acknowledges that the Organizer will not handle Players' data and will not process them for any purposes other than those specified.

19. With the act of making a purchase that contains his/her name, address, telephone number and e-mail, the Player, through his/her independent and explicit or inexplicit intention, gives consent for these data to be included in the Organizer's database, and for the Organizer to use these data during the time of conducting the present Game. By entering his/her e-mail address and telephone number, the Player may further give his/her consent for the Organizer to send him/her electronic ads for the above-mentioned purposes by electronic mail or by an equivalent means of personal communication, in accordance with the provisions of the law on electronic commerce services and according to certain aspects concerning services related to information. Data provision occurs on a voluntary basis, in the possession of adequate information. Any Player who does not wish to be informed about personal commercial offers may request that his/her data are deleted from the registry at any time, free of charge and without restriction. The Organizer guarantees that data management will be conducted in keeping with the legal provisions that are in force.

The Player acknowledges that they may be excluded from the game if he/she requests that the data needed to conduct the Game are deleted before the transfer of the Prize occurs.

20. The participant agrees that it is his/her responsibility to obtain information about the provisions of the Regulations before entering the "Scarlethill - Prize Competition Car and Luxury Holiday": he/she cannot refer to a failure to do so in order to gain advantages, and any such omissions may not cause any disadvantages to the Organizer or to any other person taking part in implementation of the Game.

22. Through their participation in the Game the Player acknowledges and accepts all the conditions of participation and data management rules laid down in these game regulations.

23. The Organizer reserves the right to change the present rules of participation and data management as well as the prizes.

*** Prizes:**

Vehicle: The Winning Player is free to choose a new vehicle (XXX) to the value of GBP 16,000. The Organizer does not specify any conditions for the selection of the vehicle, with the provision that the vehicle must be new, sold for the first time, and that the seller is an officially registered trader in the United Kingdom. The amount of the purchase price to be paid by the Organizer must not exceed GBP 16,000. The value of the selected vehicle shall not exceed the amount of GBP 16,000. The Winning Player cannot choose a vehicle of higher value and cannot contribute to the purchase cost. Any money not used for the purchase will remain in the possession of the Organizer and will not be paid to the Winning Player.

Travel:

The Winning Player is free to choose the destination and the time of travel. The prize is one trip of up to 9 days for 2 persons, which value cannot exceed the value of GBP 2,000 (for 2 persons in total). The starting and end point of the trip must be in the United Kingdom. The trip may be chosen from any official travel agent based in the United Kingdom; selection is the task of the Winning Player. Upon selection of the trip, the Winner will inform the Organizer about the chosen trip who shall agree to contact the travel agent within 3 days of notification and transfer the value of the Prize. (The Organizer shall not be held accountable for unsuccessful attempts at payment due to overbooking of any selected tri

Travelling must take place within 180 days of payment.

Travel prizes are non-returnable and non-repayable.

The travel prize is not transferable to any other person.

Any other charges connected with the Travel Prize (Visas, Transfers, excess weight charges, etc.) are not attributable to the Organizer.

The complete value of the 5 x 1 Travel Prize items is GBP 10,000.

Successful Purchase **

The Player must successfully and completely purchase a product using the www.Oxywat.co.uk website as well as truthfully enter his/her personal data. The Player must purchase least one Oxywat SET product. The ordered and paid for product must be received by the Player so that he/she can participate in the game. Any player who exercises their right of withdrawal from a purchase will be automatically disqualified from the Game.
